Membership Directory Update:

An update resulting from the change in Directors at Club Elections, some changing of Committee membership and the changing of two mandated Committee names to Membership and Advocacy respectively will be emailed to all members.

Membership Information Booklet Update:

As a result of the changes to the Membership Directory appropriate changes will be made in the Membership Information Booklet.

Presentations at the September Club Meeting:

- Summary of the Club Workshop:

Robyn will present a very comprehensive power point summary from the evaluation forms of those able to attend.

- Role and Duties of the Nominating Committee: Sandra will present a ten-minute summary to commence the lead up to Club Elections at the Annual General Meeting in April 2013 and to further presentations of similar length on **Board Position Roles and Responsibilities** (See below) until March 2013. The Nominating Committee chairman has approved this action plan. Membership Committee members will liaise with Nominating Committee members and the relevant current Club Officers, Directors and Chairman of the three mandatory Committees when planning the following presentations -

- October 2012: Cecil Club Officers
 President and Vice President
- November 2012: Chris Club Officer - Secretary
- January 2013: ? Club Officer -Treasurer
- February 2013: ? Board Members
 One-Year and Two-Year Directors
- March 2013: Current Respective Committee Chairman - Mandatory Committees - Service, Advocacy, Membership

As follow up it is suggested that both the Membership and Nominating Committees compile a display folder describing the roles, duties and responsibilities of each of the Club Officers, the Directors and the Nominating, Service, Advocacy and Membership Committees for current use and for discussion with the succeeding member upon changeover. The contents should be monitored regularly and data replaced with the latest information to maintain their currency.

It is recommended that an Evaluation Form should be completed after each Committee activity conducted throughout the year to include recommendations to either cease the activity as the goal has been attained or to improve future activity outcomes re suitability of date, venue and its equipment etc. These could be filed in the folder after subsequent discussion and reporting to the Board and Club members to guide in finetuning future planning.

"Caboolturizing" the Zonta Club of Cairns Information/Contact Brochure:

Cecil will consult with the Public Relations and Communications Committee and prepare a Draft for feedback from both this Committee and the Membership Committee. In addition to the commercially printed Club Information Brochure copies of this brochure will be distributed at Service and Fundraising activities such as Gift Wrapping and Bunning's Sausage about Sizzles when queries Zonta International and its Service Club role are made.

Christmas Fellowship Function Members' Survey:

Members will be surveyed in the near future seeking their preferences re the date, the day, lunch or dinner, the type of function and suggested venue/s whether local or further away etc.

Flowers and Cards to Members:

The Committee sends e-cards for Club members' birthdays. Following a suggestion that the Committee could also send cards and flowers to Club members as required other situations the Committee for that Board should recommends the continue this role as the President is usually the first member informed of anything relating to members and their families, has easy access to the Club Treasurer for payment purposes, usually signs such cards on behalf of the President and Members of the Zonta Club of Caboolture and has the authority of her office to manage such situations.

Whole Club Survey:

Following Zonta International recommendations the Committee plans to conduct the next whole Club survey next year. A sample survey is included in the Marion de Forest Membership Manual that could be tweaked and made relevant to our Club.
