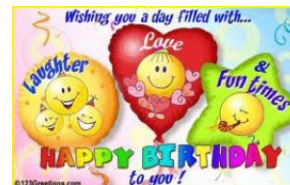

SERVICE

Discussion: Breast Cushions: We received a request from Ros Kinder to deliver an emergency supply of breast cushions to the Royal Brisbane Hospital. We were happy to oblige and Sue delivered 40 cushions on Monday the 3rd November. Sue has also picked up the stuffing from Ros Kinder, for our "stuffing day" next Sunday the 9th of November. We currently have 60 cushions stock on hand.

Discussion: Fight Like a Girl: The committee will be recommending to the club at Planning Day that we take on Fight like a Girl as a major project for 2014. Depending on funds available, we would like to introduce the program (Plan A) into 10 high schools and (Plan B) into 5 high schools. The high schools that we introduce the program to will be the schools that receive our Banksia Awards. If we are ONLY able to fund 5 programs into 5 schools, this will be done by ballot, so as to not show any preferential treatment or bias.

Christina Marshall's fee for 2013 was \$700.00 per course. The committee has taken into account that this fee may be higher in 2014, so we would like to budget for \$800.00 per course.

Discussion: Birthing Kits: The committee recommends that we increase the number of packs from 1200 to 1500 in 2015.

Discussion: Emergency Feminine Supplies: As we now have approval from the club to go ahead with Emergency Feminine Supplies, and we also have over 300 sewn bags we are now ready for a packing day to be held at Sue's home on Tuesday the 2nd of December, 9.00 a.m. for 9.30 a.m.

Patricia is to buy 1500 sanitary pads and 1500 tampons. The plan is to deliver 100 packs to both F.O.T.S. and The Haven and we will have 100 spare for stock on hand.

Discussion: Banksia Awards: The committee recommends that our annual Banksia Awards continue as normal, however, Sue & Glenda to talk to the teacher/person concerned at Bribie High School to clarify, that the school understands the criteria for these awards. (That the student is preferably from Grade 11 not Grade 12).

But we also agree that the end decision is to be left to the school.

This year the organisers of the Banksia Awards have had problems trying to find enough Zonta members to go to the Awards nights; some members have had to go to two schools. Maybe the newer Zonta members need to be informed as to their duties on the night, and, reassured that we do not have to give speeches, and it is a very enjoyable night to attend.

Discussion: Christmas Hampers: Patricia, Pam T/S and Sue will soon set a date and go shopping for the Christmas Hampers to be delivered to The Haven, F.O.T.S. and Caboolture Regional Domestic Violence Service.

Discussion: CRDVS Dinner: Lorraine had just come from a CRDVS meeting, plans are well underway and in control for the dinner. Lorraine read the program to the meeting, and the format that the night will take. We are to pay \$500.00 to CRDVS to assist with the expenses of the guest speaker. Patricia to obtain a cheque from our treasurer at the next Board Meeting to be given to Estrella on the night of the dinner.

General Business: We briefly discussed the possibility of a Grant to a young woman who is keen to improve her education or status in the community.

We will hold this over until 2015.

Our next Service Committee meeting will not be held until February 2015. The first meeting will be held on a Saturday at Waltraud's home, but the date is yet to be decided. We would like to include the two members Deb & Glenda, who aren't able to come on a Tuesday because of work commitments, so we will set a date that suits them.

Once again our sincere thanks to Waltraud for a delicious morning tea & lunch, and to Mark for his & Waltraud's kind hospitality.

Information CD/USB

At our last Zonta General meeting in October, members suggested that new members can find relevant information on the Zonta web pages - Branch, District, International. There may not be a need to have a CD/USB prepared for new members. The Committee at our meeting 11 November discussed the advantages of having a background CD/USB focussing briefly on What is Zonta and What Zonta Does - especially what our Club does. The presentation would be mainly through photographs with captions. There would be only about 2-3 USBs which could be on loan to new members, to supplement the content in the Member's Booklet and on Webpages. The USBs would also be a handy resource for members to use when telling others about our Zonta Club.

Zonta International Governing Documents

Sandra had a copy of the Governing Documents 2014-16. Any changes to governance will be studied by the Constitution/By-Laws Committee, but the Membership Committee briefly discussed the sections relating specifically to member issues. It was noted

- that the process of joining has been simplified
- that the bylaws state that women and men can join Zonta
- that the process of joining can be by application or invitation
- that eligibility for membership is simply that applicants have experience in a profession or business.

Sandra noted that our Club's Constitution already has the last point.

The Membership Committee will be studying the updated Marion de Forest Membership Manual, to clarify details of the process of becoming a member.

Suggestions from the Club Survey 2013

This is an ongoing task as implications from the survey will need to be reflected in future planning.

Future Planning

The Membership Committee will prepare a brief outline of future activities 2015 onwards for the Board to consider, and for Planning Day 2015 for members to discuss.
