## PRESIDENT'S REPORT

This has been an interesting year for the Zonta Club of Brisbane East.

For some time we have been simply continuing with our established projects and activities. We have continued to support the scholarship winners from Balmoral High School and to make and supply breast cushions to the Mater Hospital and the PA Outpatients Department as well as meeting other requests. In addition, we have supported victims of domestic violence who have sought refuge at Madonna House and are embarking on a new start by providing exit packs of kitchen equipment.

In February we participated in a planning session led by consultant Sue Shaw. As a result, we formulated a Strategic Plan to guide and inform our future activities.

Consequently we have decided not only to continue our current projects, but to also adopt several new ones. These include plans to support 16 Days of Activism in November; support for The Dress for Success Program; Support for ATSI Women's Legal and Advocacy Service and the establishment of a bursary for a student of Yeronga State High who is a migrant/refugee.

The award to the Balmoral State High School student is to be named The Beverley Farley Zonta Scholarship in recognition of a Charter Member of Brisbane East who is also a former principal of Balmoral High.

As always, projects need to be funded and we need to look to ways and means of fundraising. Thanks in particular to the past hard work of Heather Mildwaters and Denise Conroy and the support of the membership. Sadly, this year's Antiques Fair has had to be cancelled and it is obvious that other means of raising funds must be found.

A clear message from the Area Meeting was that organisations such as Zonta must meet the challenges posed by a changing society. New and innovative ways of raising funds must be found. Fortunately we are off to a positive start thanks to Irene Kinder and our Blue Illusion Fashion Event.

Our dedicated long term members have remained faithful to Zonta and we are pleased to welcome Kerstin Liebchen-Meades to our club. Although our club membership remains small in number, we are moving in a positive direction. An indication of the strength of our membership was that, of all the clubs in Areas 1 and 3, Brisbane East had the highest proportion of its members attend the area meeting in April. In the last few months we have taken several positive steps towards re-energising our club, including formulating a Strategic Plan, adopting processes for proposing and adopting projects and restructuring our meeting procedures.

In conclusion, I would like to thank all members for their support over the last two years and wish the incoming Board under Ros Kinder's leadership every success in our quest to Advance the Status of Women.

## FUNDRAISING & SERVICE

Although only small in numbers, our Cub has had yet another successful year with the continuation of our existing service projects and with fundraising even though we did not have a major fundraiser during the year.

## **Service Projects**

### a) Zonta Breast Care Cushions

Members continue to meet generally bi-monthly to stuff, sew and package our Zonta Breast Cushions which are then distributed to predominantly the Mater Private Hospital but also the Princess Alexandra Hospital as needs arise and we respond to ad hoc requests.

During the year over 700 cushions were made and delivered.

We thank Jo for hosting our working bees, Pat for cutting out the cushions, Jo's sisters who sew and stuff many of the cushions and our friends such as Maureen and Jan who come regularly to help us with this project. This support is invaluable.

During the year we have received many letters of thanks and donations from women who have received one of our cushions. To know they are of assistance to these women is very gratifying.

b) Balmoral State High School Bursaries

The Club continued with its project of awarding a scholarship to a Grade Twelve girl from Balmoral State High School to encourage and assist her to continue with further education. The scholarship provides financial support of \$500 per year over three years subject to continuing enrolment and satisfactory results.

The Club is now supporting three students with the students invited to a meeting early in each year to meet members and speak on the progress of their studies.

c) Support for Madonna House

The Club continued its support for the women staying at Madonna House. Our support included:

- Provision of Kits of household goods to assist the women leaving Madonna House to establish their own home;
- Christmas hampers for each of the women staying at Madonna House (6 families);
- Christmas gifts for the children of these women; and
- Gifts for the children to give their mother on Christmas Day.

Again the hampers and gifts were made possible by the generous donation of goods from members and friends, supplemented by funds from our Fundraising Account, and a very generous donation of chocolates from Nestle through David Kinder.

d) International Service Projects through Zonta International Foundation

The Club is committed to supporting the ZIF programs and at the end of the year when our Financial Accounts are audited will be forwarding one-third of the funds raised during the year to ZIF.

## Fundraising

Our fundraising during this past year was limited with no major fundraiser held.

- Jill continued with the sale of the Entertainment Books.
- A Crazy Whist afternoon was held at Ros' home with the dollars raised to be credited to our Breast Cushion account. A donation was received on the day which was given specifically to be credited to our Breast Cushions account.

## **Future Activities**

Following a Planning Session early in 2013, Club members were encouraged to propose service projects for the coming year. A number have been received and will be discussed at the April 2013 Dinner Meeting.

Fundraisers have also been proposed for the new Club year to boost our service account balance and allow the Club to continue with its existing projects and any new projects approved by the membership.

## MEMBERSHIP

The end of each year always brings with it thoughts about continuation of membership in the Club and Zonta International.

Sadly, at the end of the last Club year one of our Charter Members, Bev Purcell, did not renew her membership. We thank Bev for her support of the Club during her years of membership. We have two remaining Charter Members – Bev Farley and Denise Conroy.

Our Club membership is relatively small and we all need to be active in seeking out new members and to seek out members from a diversity of areas.

We welcomed MaryAnn Hill to our December Meeting and MaryAnn requested a transfer from the Zonta Club of London II back to our Club. Those who knew MaryAnn were very excited about this as she was a very active member but were also sad to learn that she had accepted a position in Papua New Guinea and would be relocating to Port Moresby. MaryAnn will continue her membership of our Club and we are now looking at technology to determine if Skype can be used to include her in our meetings.

We also welcomed a prospective member Kerstin Liebchen-Meades to two of our meetings. Kerstin approached our District Governor and Lieutenant Governor seeking information about Zonta International and was referred through to us. Kerstin has submitted an application for membership and we anticipate she will be inducted as a member early in our new year.

A number of promotional products have been developed for Club members to use and distribute to gain interest in our Club and potentially encourage new members to seek out more information about us with the intention of joining our Club.

2014 is the 25th Anniversary of our Club receiving its Charter from Zonta International. We should all be striving to build our membership back at least to the level it was on 13 March 1989.

## NOMINATING COMMITTEE REPORT

The Nominating Committee is charged with the role of presenting to the Club a Slate of Candidates for the coming Zonta year (2013-2014).

In preparing this Slate, the Committee took into consideration previous positions held by Club Members and opportunities for future development. We also had in mind the outcomes of our Planning Meeting in February and the Draft Club Strategic Plan and the future directions of the Club.

## TREASURER'S REPORT

For this year, we made an overall deficit of \$3,333.25.

This was, in part, due to donations that were made during the year from the Fundraising Account.

We made donations to 3 recipients of the scholarship who attended Balmoral State High School. Two of these students, Zenia Wood and Kaitlyn Sichter had received \$500 each in the previous year. The third recipient, Renee Cunningham, received the scholarship of \$500 for the first time this year.

In addition, we supplied Starter Kits to Madonna House which cost us \$643.50.


We also supplied toys and other items to Madonna House which cost us \$449.92.

Our sources of fundraising this year have been from:

- Crazy Whist function \$612.00
- Entertainment Books \$130.00

Our General Account has made a deficit of \$2,734.53. This is mainly due to the Audit Fee paid of \$1,280.00 which was for 2 years and the Facilitator fee paid of \$500.00. As there are still funds in our bank account, we have decided to reduce our membership fees for the 2014 year from \$170 to \$150. We still have sufficient funds in the account to cover expenses for the next few years.

### 1. SIGNIFICANT ACCOUNTING POLICIES

The financial statements are a general purpose financial report that have been prepared in accordance with the Australian Accounting Standards, other mandatory professional reporting requirements, and the requirements of the Associations Incorporations Act (Qld). The financial statements have also been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the condsideration given in exchange for the assets. The accounting policies have been consistently applied, unless otherwise stated.

The following is a summary of the material accounting policies adopted in the preparation of the financial statements.

### Income Tax

No income tax is payable as the Association is an exempt organistion under the Income Tax Act.

### Depreciation

Property, plant and equiment are brought to account at cost. Plant is derpeciated on a straight line basis over 20 years.

### Accumulated Funds

In the event of the winding up of the Association, accumulated funds will not be distributed to members. The funds are to be distributed to another body incorporated with a similar constitution and objectives as that of the current Association. Otherwise the funds are to be returned to the relevant body which originally granted the funds to the Associaton.

### AUDIT REPORT

#### Scope

I have audited the special purpose financial report of the Zonta Club of Brisbane East Inc. for the year ended 31 March 2013 as set out on pages 3 to 8. The committee is responsible for the preparation and presentation of the financial report. I have conducted an independent audit of these financial statements in order to express and opinion on them to the members of the association for the year ended 31 March 2013.

My audit has been conducted in accordance with Australian Auditing Standards to provide reasonable assurance as to whether the financial report is free of material misstatement. My procedures included examination, on a test basis, of evidence supporting the amounts and other disclosures in the financial report, and the evaluation of accounting policies and significant accounting estimates. These procedures have been undertaken to form an opinion whether, in all material respects, the financial report is presented fairly and in accordance with Accounting Standards and other mandatory professional reporting requirements and statutory requirements so as to present a view which is consistent with my understanding of the association's financial position, and the results of its operation.

The audit opinion expressed in this report has been formed on the above basis.

#### Qualifications

Various fundraising activities, particularly membership fees and dinner meetings contribute a significant amount of the revenue for the Zonta Club of Brisbane East Inc. The Zonta Club of Brisbane East Inc. has determined that it is impracticable to establish control of the collection of donations of cash prior to entry into its financial records. Accordingly, as the evidence available to me regarding revenue from this source was limited, our audit procedures with respect to cash donations have to be restricted to the amounts recorded in the financial records. In addition, donations of goods and services have not been accounted for in the financial statements. I am therefore unable to express and opinion whether donations received by the Zonta Club of Brisbane East Inc are complete.

### Audit Opinion

In my opinion, except for the effects on the financial report of such adjustments, if any, as might have been required had the limitations on our audit procedures referred to in the
