



1. What is "Zonta Says NO"?

Building off the theme of the 2013 Commission on the Status of Women (CSW) "Elimination and prevention of all forms of violence against women and girls", "Zonta Says NO" is a campaign to raise awareness of Zonta's efforts to end violence against women and girls at the club, district and international levels. It is also an opportunity to unite Zonta clubs and Zontians around the world in one common action and to promote our ZISVAW (Zonta International Strategies to End Violence against Women) projects.

2. How will the campaign assist Zonta in increasing its credibility and visibility?

The campaign will raise internal awareness among Zontians of the depth and breadth of Zonta's activities to prevent and end violence against women and girls at the club, district and international levels. Through increased visibility via the Zonta International website, The Zontian magazine, Zonta International's social media platforms and the Say NO UNITE website, Zonta will likewise raise public awareness of its efforts to prevent and end violence against women and girls worldwide, thereby increasing Zonta's global credibility as an organization working to end violence against women and girls. More visibility at the club and district levels from their participation in this campaign should also assist with membership recruitment and retention and support for Zonta's projects.

3. How is "Zonta Says NO" different from the UN Say NO – UNITE campaign?

The "Zonta Says NO" campaign is a Zonta International campaign. We will coordinate with the Say NO – UNITE campaign to highlight Zonta's efforts via the Say NO UNITE website and contribute to global efforts to raise awareness of the issue of violence against women; however, it is a separate campaign focused on Zonta's activities at the club, district and international levels. In this aspect, "Zonta Says NO" is an ownership campaign that every member can relate to.

4. What are the goals of the "Zonta Says NO" campaign?

The goal of the campaign is to raise internal and external awareness of Zonta's efforts to prevent and end violence against women and girls, locally and globally. To do so, we will aim to succeed in getting at least 40% of Zonta clubs to participate in the campaign. In addition, we will strive to get an additional 40% of clubs who do not participate in the campaign to engage in discussions about the campaign to learn what can be improved upon for potential future activities.

5. How do clubs and districts get involved?

Clubs are encouraged to participate in service and advocacy activities that focus on ending violence against women and girls from November 2012 to November/December 2013. All clubs will receive a campaign starter kit with a timeline for action and have access to examples for club activities through a special campaign section on http://www.zonta.org. Clubs can continue on with existing activities focused on ending violence against women and girls, or they can start a new service project or advocacy initiative. These activities can be shared with the Zonta International community via a special website section dedicated to the campaign. Clubs and districts can also participate in the Zonta Service Recognition Award by entering their project in the VAWG category. 



Elimination of New Pediatric HIV Infection & Prevention and Response to Survivors of Domestic and Gender Based Violence in Rwanda



Interim Report for the period of May to September 2012

2010-2012 Funding: US\$500,000 from the International Service Fund to UNICEF

GOAL:

To prevent mother-to-child transmission (PMTCT) of HIV by strengthening the early in-% of use of improved drink- fant diagnosis (EID) program and ensuring routine provision of family package services at 20 UNICEF-supported PMTCT sites and to support two newly established pilot centers in providing holistic care and support to survivors of domestic and gender-based violence.

BACKGROUND:

Rwanda has made remarkable progress in achieving Millennium Development Goals #3 and #6, which focus on gender equality and the fight against HIV/AIDS. This accomplishment is due to Rwanda's high-level government commitment to address gender inequalities and ensure equal access to HIV prevention, care and treatment services

To date, 82% of all health facilities countrywide offer family-centered PMTCT and the government has established a One stop Center (OSC) model to provide treatment, care and support to survivors of gender-based violence.

Progress in Rwanda

- Infant and under-five mortality dropped to 50 and 76 deaths per 1,000 live births, a major improvement from 2005 rates, which saw 86 and 103 deaths per every 1,000 live births. The UN Inter-Agency Group on Child Mortality Estimation (IGME) has projected Rwanda's infant to under-five mortality rate for 2011 at 54 and 38% per 1,000 live births.
- Three-fourths of the population now live within five kilometers of a health center and 78% of households have health insurance. an increase from 68% in 2007-2008.
- 90% of all children under one are fully immunized.

- In 2011, primary school enrollment and completion rates remained high at 95.4% and 78.6%. Dropout rates steadily decreased from 12.2% in 2009-2010 to 11.3% in 2010-2011.
- The government implemented safety nets that reach at least 45,000 of the most vulnerable children and provide educational and vocational training, access to health insurance and counseling.
- 85% of HIV-infected pregnant women received anti-retroviral therapy (ART) during pregnancy and at the time of child birth at the end of 2010.

Challenges Still Remain

- About 30% of pregnant women are not accessing HIV testing.
- 3% of Rwandans age 15-49 are HIVpositive.
- Only 12% of youth aged 15-24 have comprehensive knowledge of HIV/AIDS.
- 65% of all cases of GBV treated at the OSC in Kigali are children; a majority of them are girls.

PROJECT ACTIVITIES & RESULTS

Eliminate MTCT of HIV in Rwanda by 2015

- UNICEF supported a national study to determine the effectiveness of the PMTCT program. The study measured early transmission rates among HIVexposed infants at 6-weeks of age and looked to determine factors associated with early HIV transmission from mother -to-child. 1,561 mother-baby pairs enrolled in the study and 699 samples were collected.
- Six districts were supported to develop a three-year operational plan for the elimination of MTCT.

- Early infant diagnosis (EID) programs are being implemented in two districts. EID programs offer a diagnosis of HIV from 4-6 weeks of age, which facilitates provision of life-saving care to infants and enables access to HIV prevention information.
- Project funds were used to support the routine provision of PMTCT services to approximately 8,500 pregnant women in 20 health centers. From April to August 2012, 95% of patients were counseled and tested for HIV and 90.8% of their male partners were also tested. 99% of them and 77% of their newborns received treatment.
- Ten new PMTCT sites initiated the family package approach. Two health care providers and 19 peer educators were trained per site on the family package approach. In the 12 existing sites, 87 association members were trained on income-generating activities management.

Reduce incidence and lessen the impact of gender-based violence

- Support was provided to increase access and quality of services for survivors of violence, with increased safety and ongoing community awareness.
- Technical and financial resources were provided for survivors of violence upon returning to their community to support their reintegration process.
- Support was provided to the government in expansion of OSCs for the prevention of, and response to, domestic and gender -based violence in all five provinces of Rwanda.
- The Kacyiru OSC gave high priority to awareness–raising and sensitization. The Center organized awareness raising campaigns in the three most vulnerable districts in the City of Kigali, particularly for the Community Policing Committee, the local leaders, the Anti-GBV committees on survivor referrals, and approximately 500 local leaders since the beginning of 2012.
- Data from the Isange OSC, which opened in July 2009, shows 5,482 survivors treated as of August 2012 (95% women and girls, 65% are children).
- The Isange OSC maintained a 24-hour hotline for survivors of GBV. An average

- of eight calls were received per day; 90% of callers were women or girls.
- Steps were taken toward finalizing the National Scaling-Up Strategy for OSCs to ensure harmonized and multidisciplinary OSCs throughout Rwanda.
- Strengthened capacity of OSC personnel in the areas of trauma focused mental health and psychosocial support.
- Four OSCs are currently operational in Rwanda, and six more are planned to open in 2012-2013.
- The Gihundwe OSC has conducted 310 follow-up home visits from January to July 2012 and the Isange OSC has conducted 99 follow-ups. The visits aimed at supporting survivors in their reintegration within their house and community after the traumatic event.
- Both the Gihundwe and Isange OSCs set up a support-fund for vulnerable women to access services free of charge. The fund supports these women with transportation costs, food and shelter.

Future Activities

UNICEF will continue to support the PMTCT of HIV, as well as strengthen efforts to reduce incidence and lessen the impact of GBV.

Specific plans for the **PMTCT component**:

- Continue supporting family-centered services in 20 hard-to-reach sites.
- Analyze data from the PMTCT impact study.
- Establish a district-wide surveillance system for HIV infection in children.
- Improve EID programs that are currently implemented in two districts.
- Disseminate the national strategic plan for elimination of MTCT of HIV.
- Develop an operational plan to eliminate MTCT of HIV in four districts.

Specific plans for the **GBV component**:

- Work closely with the Ministry of Health to continue planning activities to ensure standardized care and support to survivors of GBV.
- Evaluate the Isange OSC.
- Continue to train the intervention team to ensure quality and coordinated services by all OSC staff.
